Juror: CHARLES W. “CHUCK” EISEMANN

A San Antonio native, Chuck Eisemann has lived or traveled in 75 nations, where he has had opportunity to view the great sculptural works in the Americas, Europe and Asia. From that seed he began his interest in sculpture, expanding into the arts in general. When first moving to Dallas in 1966, Chuck joined the 500 Inc., and from there built a life-long commitment to this area’s arts environment. As part of the Eisemann Family Foundation, he has provided support to many arts organizations in North Texas, including artists in music, dance, visual arts and sculpture.

Recognized by the Richardson Chamber of Commerce as “Richardson 2001 Citizen of the Year”, Chuck Eisemann continues to support and encourage arts excellence, and is a member of Texas Sculpture Association. As a stone sculptor, Chuck works with alabaster, Italian marble, and recently, blue onyx.

Venue: ArtCentre of Plano is in its new location on 18th St. at Ave. K, just north of downtown Plano, in a beautifully renovated Victorian house. See more at www.artcentrefplano.org/.

Eligibility: Must be a member of Texas Sculpture Association – membership application is on this form. Entry is open to all professional and amateur

artists age 16 and over. Pedestal, floor and wall sculpture accepted. No strict definition of sculpture – all media are acceptable. Artwork must be original and created within the last two years.

Regulations: Indoor sculpture, or component pieces, must be able to fit through a 12’x4’ door opening. Outdoor sculpture should be heavy and not easily movable. Porch has a motion detector; the yard is open to the public.

For pedestal work: artist-supplied pedestals **must** complement the artwork and be of high quality; **or** artist may **rent** a pedestal from Texas Sculpture Association (see application.) Wall sculpture must be ready for hanging, and include appropriate hooks.

Acceptance of sculpture into the show, and the number of pieces chosen, will be by decision of **Juror, Charles W. Eisemann**. The juror’s decision is final. Selected artwork must be exhibited for the entire show. Sales of artwork will be through ArtCentre of Plano.

Fees on Work Sold During This Show:

25% of the sales price will be contributed to ArtCentre of Plano; An additional 10% of the sales price will be contributed to The North Texas Food Bank.

Entry Fees: \$15/ entry, or three entries for \$35.
All fees are non-refundable.

Pedestal Rental Fee: \$15/pedestal, due upon acceptance of work into the show.

Membership Dues for 2011 (if not currently a member.)

Image Transmission: High quality, high resolution – 300 dpi/large file size – JPG images of artwork must be submitted on CD or to nan@nan-art.com or through the TSA web site at www.txsculpture.com. No slides please. Each picture should be saved with the following information:

“Artist name – name of piece – ArtCentre.”

Artist may submit 4 views of various angles of each sculpture.

Artist **must** submit pictures of all artist-supplied pedestals, including a picture of the sculpture on the pedestal. Juror has the right to reject any pedestal.
